MINUTES.

JEFFERSON COUNTY, ALA., October 19th, 1893.

The Sulphur Springs Baptist Association met in the Mount Zion church house in said county and State at 11 a. m., on above date, and was called to order by Eld. W. J. McCrary, and heard the introductory sermon preached by Eld C. A. Burns, followed by S. L. Waldrop. Text 11th verse and 12th chapter of Romans.

On motion adjourned for dinner.

AFTERNOON SESSION—2 P. M.

The delegates came together by singing in the church house.

The Moderator called the body to order, and offered prayer and praise to the giver of all good and perfect gifts, after which he called for letters from the various churches, and appointed J. F. McNeal and W. R. Martin reading clerks.

Received letters bearing names of delegates from the following churches, to-wit :

Mount Zion church, Liberty church, Spring Dale church, New Prospect church, Arkadelphia church, Mount Joy church, Oak Bower church, Calcedona church, Good Hope church, Mineral Spring church, Mount Hope church, Cane Creek church, Mount Olive church, Mount Pisgah church, Harmony church, Mount High church, Chalybeate Springs church, Sulphur Springs church, New Bethel church, Union church, Jefferson county.

On motion, recognized Eld. C. A. Burns as a delegate from Union, Blount county.

On motion, recognized W. C. Wingo and S. L. Waldrop as delegates from Antioch church without a letter.

On motion, elected Moderator, Clerk, Corresponding Secretary and Treasurer, which resulted in the choice of Eld. W. R. Fullmore, Moderator, J. M. James, Clerk and Treasurer, and Bro. W. R. Martin, Corresponding Secretary.

On motion, amended the regular order of business so as to call for new churches at this juncture of time whereupon the following letters were presented, to-wit: One from Brook Sides presented by Rev. W. C. Wingo (proxy delegate,) and on motion, received the church into the Association, one from New Hope church with delegates, one from Walls Union church with delegates, one from Sardis church with a list of delegates.

On motion, adjourned to meet Friday morning, 9 o'clock.

FRIDAY.

MORNING SESSION—9 A. M.

The body came together by singing a hymn, and the Moderator called the house to order and offered prayer led by Rev. D. L. James. After which called for correspondents and on motion received Rev. Dock McCrary, from Clear Creek Association.

On motion, received Rev. D. L. James and Eld. I. Persell as visiting ministers from our association.

A motion was offered to hear Eld. W. J. McCrary make a statement of complaints against New Bethel church, he having objected to its delegates sitting as members of the body while in session. The motion was lost, and the privilege not granted as gospel steps had not been taken.

On motion, returned correspondents.

On motion, received Rev. Robert Jones as a correspondent from Cullman Association.

On motion, received a letter from Union church with brother Wm. M. Keith as a delegate from Blount county.

The Moderator called for reports of the various committees.

On motion, granted the Executive Board more time.

No other reports being offered, the Moderator excused Rev. S. L. Waldrop, to go home on account of sickness of his family.

On motion, adjourned for dinner.

AFTERNOON SESSION—2 P. M.

The delegates resorted to the school house near the church house to occupy it for the transaction of business, the Moderator in the chair (W. R. Fullmore) who called the body to order and offered prayer led by Rev. M. M. Russell.

On motion, received Antioch's church letter with Bro. W. W. Statum as bearer and delegate.

On motion, received a letter from Pleasant Valley church by politeness of Eld. T. D. Holcomb and no delegates.

Heard report on missions, and on motion, received the report for discussion. Having had several speeches from the brethren the report was laid on the table until Saturday morning, by a move and second of the body.

On motion, adjourned for the night.

SATURDAY.

9 a. m.—The delegates met in the school house again for business, that the church house might be had for preaching. The Moderator called the body to order and offered prayer.

A motion was offered to take up the missionary report for a second hearing. Carried, and the Clerk was ordered to read it again.

After which a move was offered for its adoption and carried.

Heard report on Documents; the report was received and adopted, with the following amendment, to-wit: That the Moderator appoint a committee of two for the purpose of adjusting the trouble between the churches mentioned in the report, who appointed brethren to-wit: Rev. J. W. Trotter and Rev. J. S. Jernigan.

All ordered by move and second of the body.

Heard report on Sabbath schools; on motion, received the report and laid it on the table until 9 o'clock Sunday morning.

Heard report on Temperance; on motion, received and adopted the same.

See report (7.)

Heard report on Superannuated Ministers; on motion, received and adopted same.

On motion, appointed the next meeting of the Association to meet with Mount Joy church commencing on Thursday before the 4th Sunday in October, 1894, about ten miles west of Blount Springs in Blount county, Alabama, on the L. & N. R. R. Said church is in Blount county, Alabama. And on motion, appointed Eld. C. A. Burns to preach the introductory and Rev. D. L. James, his alternate.

On motion, appointed Eld. I. Persell to preach the Missionary sermon and Eld. W. R. Fullmore as alternate.

MISCELLANEOUS.

On motion, the body granted all the churches south of the Warrior river letters of dismissal when desired for the purpose of organizing a new association; also granted letters to any other churches near the said river for the said purpose when desired.

On motion, granted New Bethel church a letter of dismissal at their own request, desiring to belong to an association that would co-operate with the State Mission Board.

On motion, offered a vote of thanks to Mount Zion church

and community for their kind treatment and hospitality while we had our stay with them.

On motion, took up collection for missions, received \$2.91.

On motion, took up collection for Eld. C. A. Burns, received \$4.86.

Heard report of Committee on Finance. For minutes \$32.40. Report received and adopted.

On motion, ordered the clerk to have five hundred copies of the minutes printed; and allow him to keep ten dollars for his services.

Adjourned in the usual form to meet in Sabbath school mass meeting Sunday morning, to discuss the Sabbath school report, then to go home, to meet at the place and time above designated.

REPORT ON MISSIONS—1.

We, your committee, beg leave to submit the following report.

She promise of God to all the families of the earth is in exact keeping with the terms and scope of the great commission, if all the families of the earth are included in the promise first declared, they are likewise included in the commission finally issued. What God has promised He will fulfill; what He has purposed He will accomplish, but His promise is not to be considered independent of its divinely sanctioned agencies and contingencies. There is a sphere in which God's purposes moves independent of human effort and irrespective of human opposition; but in redemption God has demanded into the range and sphere of human activity and energy and has invoked the instrumentality of human effort. Redemption as presented in the Scriptures, first appears in the form of a blessing promised in the call of Abraham. In after times it assumes the form of a command. A long period of time separated the 12th of Genesis from the last of Matthew, but a continuity of purpose extends over intervening ages, making Revelation luminous in its declarations and imperative in its commands. God's purpose first took the form of a blessing promised. In its last analysis he threw it into a form of a command: "Go ye into all the world and preach the Gospel to every creature. The scope of the one corresponds precisely with the scope of the other. The promise of the commission to the disciples might clearly and comprehensively be understood and executed, as his purposes approach their consummation, there seems to be

an increase of energy exerted and a reinforcement of the efforts put forth by all the Associations of the Missionary Baptist, but the Sulphur Spring Association has done but little, not enough to report, in the last year, but the promise of God then is to be fulfilled in the execution of the commission. In this way the promise of God is made the obligation of his people to the sources and faith of his people—to all people salvation is to come. It is the promise of God, and it becomes the promise of his people in so far as he has made it a missionary obligation. God has committed and pledged the resources and efforts of his people in the Mission work. The great commission must stand until it is finally and fully executed, or until it is revoked.

It is the order of the day or rather the order of ages. The promise of God presents to us the extent of Christian obligation in definite form, and the possibilities of missionary effort. The time was when humanly speaking Christendom was a future possibility. In the execution of the commission; in the preaching of the gospel, the boundary lines of Christendom have been established upon the map of the world as they appear to-day. The religions of nations have been overturned; superstitions have vanished; the churches of the Living God have been planted among the ruins of Pagan temples and upon the wild wastes of savage lands, and we are not doing anything in this grand work for the Lord. The Lord's people are calling for help, but in the past we have turned a deaf ear. Will the churches of the Sulphur Spring Association continue to refuse the call of the brethren and sisters any longer. Brethren and Sisters, the Lord comes to you with his pierced brow and bleeding hands and calls for help, and we refuse to help. What is the penalty? You are cured with a curse. The command is to "go ye into all the world and preach the Gospel to every creature." I pray that we may obey the command of God in spreading the Gospel of the Son of God.

"The battle cry is sounding, we hear the sound afar;
Let every one enlisting prepare for Zion's war;
Then raise the Gospel banner till all around can see,
Our Captain He will lead us forth to victory."

We ask this body to co-operate with the State Mission Board.

Our means are short, as you know we have not received any money the past year, and we will owe our missionary more than we will have on hand. We do earnestly ask this body to pay in enough at least to satisfy our debt with him. We, further, would suggest to this honorable body that they vote co-operation with the State Mission Board, and also contribute liberally to the mission cause to supply the starving destitutes of our territory, because we see no other way to carry on our mission work in and around our Association.

REPORT OF OUR MISSIONARY—4.

Taking charge of the mission work in our bounds immediately after the first Sunday in Sept. 1893, I canvassed and preached in the destitute regions and to as many churches as practicable, worked thirty days, preached 82 sermons, delivered several lectures and exhortations, conducted one funeral, made many visits and private mission talks, traveled 320 miles. At Sanders school house they will soon organize a church. At Damascus, and near Marble Town there are good prospects of Baptist churches being organized. provided they can have Baptist preaching and faithful work by some Baptist preacher. Besides these three places the greatest need of a missionary is to indoctrinate the churches on the all important subject of mission work and system of paying what they owe to the Lord, to carry on this work at home and abroad. I would advise that our association co-operate with the State Mission Board, and make a powerful effort to keep a man in the field all the year or at least eight months, omitting the Spring if any, thus giving the missionary an opportunity to make a crop, etc.
